
Dear Chair Anderson:

Advisory Neighborhood Commission (ANC) 6B request that the ABRA Board (Board) extend the petition date until September 23, 2019 in order to permit the Applicant and the ANC 6B to hold a community meeting to answer questions and discuss concerns about the size and capacity of the summer garden, the noise concerns with many patrons, hours of operation, and similar issues related to the operations of the Establishment. The petition deadline is currently set for July 29, 2019 but the Applicant in coordination with ANC 6B has organized a community meeting for August 1, 2019.

We would note for the Board that due to an Administrative error, this case was inadvertently left off the official Agenda for our July meeting. As a result, no official vote to request the extension was taken. We sincerely apologize for the error and request that the Board grant our request for an extension of the Petition deadline. In addition, ANC 6B's ABC Committee Chair and the Applicant met to discuss their proposed plans and mutually agreed to request an extension of the petition deadline for the reasons stated above. With this letter, we request that the Applicant confirm the agreement with the ANC to defer the petition deadline to September 23, 2019.
