 - 1) Noah Glasgow, of the Mayor's Office of Community Relations and Services. Glasgow-
 - a) Made the following announcements: Mayor Bowser--
- 1-- Has called on Congress to preserve the current 70% Federal Matching Annual Percentage for Medicaid instead of cutting it from 70% to 50%.
 - 2-- Will "soon" release her proposed Fiscal Year 2026 budget. It will include-
 - a-- \$100 million for the Housing Trust Fund.
 - b-- Full funding for the Pre-K Enhancement and Expansion program.
 - c-- \$1.5 million for a master plan for Southwest DC.

- d-- \$171 million for a Capital One Arena improvement.
- e-- \$850 million to accommodate the NFL's Washington Commander's return to the Robert F. Kennedy Stadium site.
- b) Gave reasons to support the mayor's agreement with the Washington Commanders for a new professional football stadium on the Robert F. Kennedy stadium site, including that--
- 1-- The Commanders' return to DC will help replace lost federal jobs; in the future, Glasgow predicted, spectator sports will be "a huge driver of DC's economy."
 - 2-- The deal includes transportation improvements.
 - a-- Three new parking garages, with revenue going to DC.
 - b-- Improved mass transit.
 - (1) Metrorail.
 - (a) Redevelopment of the Stadium-Armory station.
 - (b) A new station on Oklahoma Ave., NE.
 - (2) H Street streetcar: expansion to Minnesota Ave., NE.
 - 3-- The Commanders themselves, not DC, will pay for the new stadium's actual construction.
 - c) Regarding the plan to build a new NFL stadium on the Robert Kennedy Stadium site, promised to--
 - 1-- Provide details at a later date about the environmental impact of building a new stadium on that site.
 - 2-- Learn if current plans would retain, as "green," the current Anacostia Trail.
- 3-- Make sure the mayor considers having DC partly control a new stadium, with the option of using it, on the 40-plus weeks each year the Commanders aren't playing there, for such attractions as Meow Wolf.
 - 2) Kimberly Kennedy, of the Office of Councilmember Charles Allen, reported on--
- a) DC's budget for Fiscal Year 2026, which starts October 1, 2025. Once the mayor releases her proposed budget, Councilmember Allen will hold a town hall on the budget.
 - b) Two bills recently introduced by Councilmember Allen: to--
 - 1-- Raise safety standards for e-bike batteries, to reduce the risk of fires from overheating.
 - 2-- Automatically enroll DC households in a utility-discount plan.
- c) Civil lawsuits initiated by the DC Attorney General, under the Strengthening Traffic Enforcement, Education, and Responsibility Amendment Act of 2024, against scofflaw drivers living outside DC.
- d) Preparation, by the Departments of General Services and of Parks and Recreation, of plans for a Rumsey Aquatic Center second floor, in response to a letter from Councilmember Allen demanding such a plan.
- 3) Anthony ("AJ") Orlikoff, Director of Programming at the Congressional Cemetery, an official partner for World Pride 2025, announced upcoming Pride Month events at the cemetery, including-
 - a) A May 22 lecture with the title Pink Triangle Legacies.
 - b) LGBTQ+ tours May 28 and June 2 and 7.
 - c) The DC Front Runners 5K run June 1.
 - d) The Gays in Graves festival June 21.
- 4. Presentation: St. Peter School Renovation. Project manager Kristine Adey led the presentation. She was joined by school principal Karen Clay, land-use counsel Jeff Utz, REQUITY Real Estate's Sherry Rutherford, and architect Meagan Jancy. The school's 422 3^d St., SE, building dates from 1867. St. Peter renovated in 1923 and built an addition in 1936. The building has no indoor gathering or play space. The mechanical systems are old and the 1936 addition doesn't align with the original building.

Renovation plans include a new three-story addition on space currently used for a playground. Renovation will require a special zoning exception. The school expects to meet with the Historic Preservation Review Board in May and with the ANC again in June, and to get a Board of Zoning Adjustment decision by fall 2025. St. Peter hopes to break ground in summer 2026 and to finish the renovation by summer 2028. Staff and students will occupy the school throughout.

Commissioner Sobelsohn moved/Commissioner Wolanin seconded to amend the agenda to move immediately to the report of the Alcoholic Beverage and Cannabis Committee. The motion passed 9-0.

As a backup in case the extension is denied, Commissioner Sobelsohn moved/Commissioner Wolanin seconded to send the Alcoholic Beverage and Cannabis Administration a letter that ANC 6B neither endorses nor opposes the license renewal. That motion passed 9-0.
- b) Ted's Bulletin. Commissioner Sobelsohn moved/Commissioner Pastore seconded to request a 60-day extension of the alcoholic-beverage license-renewal application of TB Capitol Hill, LLC, trading as Ted's Bulletin, 505 8th St., SE (ABRA-108110). Commissioner Sobelsohn moved/Commissioner Pastore seconded to amend the motion by adding a protest of the application, on the grounds of potential effects on real-property values; on peace, order, and quiet, including noise and litter; and on residential parking needs and vehicular and pedestrian safety; and also on grounds of possible violations of DC Code §§ 25-313 and 25-315; and to designate Commissioners Sobelsohn and Pastore and ANC 6B Alcoholic Beverage and Cannabis Committee Resident Members Ellen Opper-Weiner, Chuck Burger, and Katherine Szafran as ANC 6B representatives. The motion to amend passed 8-1, with Commissioner Sroufe opposed. The underlying motion passed 8-0, with Commissioner Sroufe abstaining.

Sroufe, and ANC 6B Alcoholic Beverage and Cannabis Committee Resident Chair Ellen Opper-Weiner as ANC 6B representatives. The motion passed 6-0, with Commissioners Krebs, Ryder, and Hughes abstaining.

Commissioner Ryder called the meeting to order at 7:06 p.m.

- 1. Adoption of Agenda. Commissioner Sobelsohn moved/Commissioner Sroufe seconded to approve the agenda as modified by the addition of a Consent Agenda. The motion passed 8-0.
- 2. Announcements. Commissioner Sobelsohn announced that his appointees to the Alcoholic Beverage and Cannabis Committee, Resident Member Katherine Szafran and Alternate Resident Member Chuck Burger, have resigned their positions, prior to switching them.
- 3. Consent Agenda. Commissioner Sobelsohn moved/Commissioner Hughes seconded to approve the Consent Agenda as modified. The motion passed 8-0. The Consent Agenda included Commissioner Sobelsohn's appointment to the Alcoholic Beverage and Cannabis Committee of Chuck Burger as Resident Member and Katherine Szafran as Alternate Resident Member.

4. Resolutions.

- a) Military Parade on Trump's Birthday: Commissioner Krebs moved/Commissioner Sroufe seconded to postpone this matter indefinitely. The motion passed 3-2, with Commissioners Ryder and Sobelsohn opposed, and Commissioner Gorman and Mareino recused.
- b) Mailbox at 5th and D Streets, SE: Commissioner Sobelsohn moved/Commissioner Krebs seconded to endorse a resolution, attached to these minutes, that calls on the US Postal Service (USPS) to expedite acquisition of a new e-lock for, and replacement of, the mailbox at that streetcorner; and on DC Delegate Norton, DC's Shadow Senators Paul Strauss and Ankit Jain, and DC's Shadow Representative Oye Owolewa to exert their influence to pressure USPS to expedite replacement of the mailbox. The motion passed 5-1, with Commissioner Sroufe opposed and Commissioner Gorman and Mareino recused.
- c) Fair Swipe Act: Commissioner Sobelsohn moved/Commissioner Pastore seconded to endorse a resolution, attached to these minutes, supporting Ward Six Councilmember Charles Allen's Fair Swipe Act of 2025, B26-138, which would limit the surcharge credit-card companies and banks can impose for use of their credit and debit cards, so that this surcharge no longer includes the portion that covers taxes and tips; and urging the DC Council to pass this bill at the earliest opportunity. The motion passed 8-0.
- d) RESALE Amendment Act: Commissioner Mareino moved/Commissioner Sobelsohn seconded to endorse

a resolution, attached to these minutes, supporting Ward Six Councilmember Charles Allen's Restricting Egregious Scalping Against Live Entertainment (RESALE) Amendment Act of 2025, B26-0224, which would limit a reseller's markup to ticket's face value plus 10%; require that only people who already have a ticket can resell it; require anyone who annually resells 50 or more tickets to register with DC's Department of Licensing and Consumer Protection; and urging the DC Council to pass this bill at the earliest opportunity. The motion passed 8-0.

- e) RFK Stadium Redevelopment: Commissioner Sobelsohn moved/Commissioner Hughes seconded to endorse a resolution, attached to these minutes, that urges the DC Council to reject the current tentative agreement between DC and the Washington Commanders, an agreement under which DC would contribute \$1 billion to a new football stadium in Washington, DC; to spend that \$1 billion instead to facilitate the building of mixed-use housing, neighborhood-serving retail, and open green spaces on the Robert F. Kennedy Stadium site; and to require any developer of the RFK site pay rent consistent with the land's value. Commissioner Hughes moved/Commissioner Sobelsohn seconded to amend the resolution to remove the word "occupant" from that third part and replace it with the word "developer." The motion to amend passed 8-0. Commissioner Gorman moved/Commissioner Sobelsohn seconded to amend the resolution to add a fourth part, urging the DC Council, as soon as possible, to issue a request for proposals to redevelop the stadium site. The motion to amend passed 8-0. The underlying motion passed 8-0.
- f) Rumsey Aquatic Center: Commissioner Sobelsohn moved/Commissioner Hughes seconded to endorse a resolution, attached to these minutes, that urges the DC Department of Parks and Recreation (DPR) to include a second floor in plans to renovate the Rumsey Aquatic Center; encourages all Ward 6 residents and all Ramsey users to sign a petition, circulated by Councilmember Allen, calling for a second floor; and that authorizes the ANC 6B chair to sign that petition on behalf of the ANC. Commissioner Krebs moved/Commissioner Mareino seconded to amend the resolution so that, instead of "urging" others to sign the petition, it only "encourages" others to sign the petition. The motion to amend passed 8-0. The underlying motion passed 8-0.
- g) Overnight Commercial Deliveries: Commissioner Sobelsohn moved/Commissioner Hughes seconded to endorse a resolution, attached to these minutes, that urges the CVS at 661 Pennsylvania Ave., SE, to stop deliveries between 6:30 p.m. and 7 a.m.; the DC Council to enact legislation protecting residents from "unreasonable" interference with their sleep from overnight commercial deliveries; and the DC Department of Licensing and Consumer Protection to enforce existing noise regulations against that CVS. Commissioner Sobelsohn moved/Commissioner Hughes seconded to place this resolution on the agenda for ANC 6B's July 8 meeting. The motion passed 6-2, with Commissioners Mareino and Sroufe opposed.
- h) Arthur Capper Interim Library: Commissioner Sobelsohn moved/Commissioner Pastore seconded to endorse a resolution, attached to these minutes, urging the DC Public Library (DCPL) to provide portable air-conditioners and fans to obviate the need ever to close the interim library for excess heat; the DC Council to pressure DCPL to keep the interim library open throughout the summer; and DPR to do what will keep the temperature at the interim library below 80° Fahrenheit. Commissioner Gorman moved/Commissioner Sobelsohn seconded to amend the resolution so, instead of urging the DC Council to "compel" DCPL to keep the interim library open during summer it urges the Council to "pressure" DCPL to keep the library open during summer. The motion to amend passed 7-1, with Commissioner Mareino opposed.
- 5. June agendas. Commissioner Sobelsohn moved/Commissioner Krebs seconded to approve proposed June agendas for ANC 6B and its committees and taskforces. The motion passed 8-0. The proposed agendas are attached to these minutes.
- 6. Adjournment. Commissioner Sobelsohn moved/Commissioner Ryder seconded to adjourn. The motion passed

8-0. The meeting adjourned at 9:30 p.m.

RESOLUTION Approved by ANC 6B June 10, 2025

To Save Up to \$66 Million of Tax Dollars Slated for a Military Parade on DC Streets Not Built for Military Vehicles

WHEREAS, to celebrate the Army's 250th anniversary, the United States Army has scheduled a military parade, from Arlington, Virginia, to the National Mall, on June 14, 2025, President Donald J. Trump's 79th birthday, and

WHEREAS, the Army expects its parade to include 6,600 soldiers, 150 vehicles, and 50 helicopters, and

WHEREAS, Department of Defense officials estimate individual Army units will spend up to \$45 million to hold this parade, and

WHEREAS, estimates of the damage from the parade, to repair roads not built for military vehicles, range from \$16 million to \$21 million, and

WHEREAS, the District of Columbia's Chief Financial Officer estimates that federal government personnel layoffs will already cost DC, in lost tax revenues, \$1 billion over four years, and the U.S. House of Representatives has already interfered with the DC budget, removing \$1 billion from the 2025 operating budget, and

WHEREAS, military parades are more typical of authoritarian governments than of democracies,

THEREFORE, BE IT RESOLVED--

- 1. Advisory Neighborhood Commission 6B urges the United States Army to cancel its planned June 14 military parade, or in the alternative to relocate the parade entirely outside the District of Columbia, and avoid damaging DC's streets.
- 2. If the parade takes place in DC--
- a. Advisory Neighborhood Commission 6B urges the United States Army to commit to immediate repairs of any damage to the streets of DC, and
- b. To the extent any part of the DC government takes responsibility for repairing its streets, Advisory Neighborhood Commission 6B urges Congress to ensure full reimbursement of the DC government before the end of Fiscal Year 2025.

To urge the DC City Council to maintain DC's Sanctuary City Status Be It Resolved by Advisory Neighborhood Commission 6B

WHEREAS, Washington, DC has long upheld its status as a Sanctuary City, ensuring that all residents – regardless of immigration status – are treated with dignity, protected from unjust targeting, encouraged to seek city services without fear of deportation, and ensured due process under the law.

WHEREAS, the District's policies limiting cooperation between local law enforcement and federal immigration authorities reflect community priorities, promote public safety, and encourage trust between immigrant communities and government agencies.

WHEREAS, DC Mayor Muriel Bowser in the Grow DC Fiscal Year 2026 Budget proposal has, in Sec. 3052, proposed repealing Section 7 of "An Act To create a Department of Corrections in the District of 3678 Columbia" (D.C. Law 19-194; D.C. Official Code § 24-211.07), which would remove the requirement that city agencies refrain from cooperating with federal immigration enforcement unless a judicial warrant is present.

WHEREAS, there is ample evidence and many ongoing judicial proceedings demonstrating that people, including American citizens, have been detained and deported by federal immigration authorities in an unjust manner lacking in due process.

WHEREAS, numerous studies and law enforcement professionals affirm that sanctuary policies enhance public safety, as immigrant communities are more likely to report crimes and cooperate with investigations when they do not fear deportation

THEREFORE, BE IT RESOLVED, THAT ADVISORY NEIGHBORHOOD COMMISSION 6B URGES THE DC CITY COUNCIL TO -

Reject the proposal to repeal Section 7 of "An Act To create a Department of Corrections in the District of 3678 Columbia" (D.C. Law 19-194; D.C. Official Code § 24-211.07), and

Affirm that local elected officials will do everything in their power to protect our communities and prevent violations of human and constitutional rights.

3. Renovation Update

a. DCPL representative Jaspreet Pahwa provided an update on construction at the Southeast Library by going through the DCPL June 6, 2025 Southeast Library Modernization Construction Updates document. (Available at https://www.dclibrary.org/news/southeast-library-modernization-project and specifically https://drive.google.com/file/d/1laLL9DeNGi_jFsJPAUn4G-HT1lxRvtim/view). DCPL and W-T representatives reviewed the construction progress since the prior Task Force meeting and previewed the upcoming work. Ms. West and Mr. Gregory provided an update on the planned relocation of the Washington Gas pipeline. A permit for the work has been secured and Infrasource, Washington Gas's contractor, is waiting on final authorization from Washington Gas. Both Infrasource and Washington Gas are currently projecting work June 16th through the end of June, with possible extension into July under worst case scenarios. Washington Gas committed to keeping Commissioner Sobelsohn updated. There were no pedestrian safety updates. A crane will be installed on June 12th and will be onsite for a few days. The crane will be on D street and will be similar in size to previous cranes. Regarding traffic around the crane, Ms. Bosnick stated there will be flaggers for a few hours, but at least one lane will be open. Ms. Pahwa noted that the next update will not be issued until July 25th. Ms. Pahwa and Commissioner Sobelsohn discussed the planned ANC testimony at the upcoming budget hearing. Ms. Pahwa clarified that it is not DCPL's intention to hold the library from opening long after construction is complete, but construction schedules and operational budgets are still uncertain and these impact the opening date. The taskforce discussed the best approach to the testimony and agreed to finalize it before the budget hearing on June 10th. Some unexpected events have occurred in the recent month, including excessive rain days and multiple break-ins. However, the impact of these delays will not be known until the building is water tight in mid-summer. A police report has been filed for the break-in. W-T has clear footage of the break-in. DCPL and W-T are considering private security and asking MPD to patrol the area more often.

4. D Street Issues

a. Traffic flow & parking enforcement

- i. Mr. Schwab believes parking enforcement has been limited during the renovation. Additionally, one lane of traffic adjacent to the construction (eastern end of 1600 block, by CVS) is of concern. There have been no accidents so far due to the caution of drivers, but visibility is very limited.
- ii. Mr. Schwab is not concerned about impacts of the crane on traffic. In the past, cranes have been inside the perimeter of the construction fence.

b. CVS middle-of-the-night deliveries.

i. Mr. Schwab will follow up via email. CVS has not had any night time deliveries in the past week, which is a welcome change.
